

9.07 GARBAGE DISPOSAL

Garbage shall be disposed of in one of the following described methods:

(1) AUTOMATED CONTAINERS.

(a) The Village will provide for curbside collection of garbage. Any solid waste generator who desires to use curbside collection must subscribe for this service with the Village. The subscriber shall pay a user fee to the Village which shall be collected with property taxes. The container shall be furnished by the licensed waste hauler contracted by the Village.

(b) Only garbage may be placed in the automated containers and all garbage to be disposed of through curbside collection must be placed in the automated containers. The automated containers will be emptied once per week by the licensed waste hauler. The automated container shall be placed at the curb line in the direction indicated on the container after 2:00 p.m. on the day before collection and before 5:00 a.m. on the collection day.

(c) Multi-Family Dwellings of four (4) or more units shall require a dumpster sized to provide the equivalent of a ninety (90) gallon can per apartment unit. If the use of a dumpster is not workable because of space requirements, the owner may select the option of using individual containers. There shall be one (1) container for each residential unit, properly sized for the waste materials generated.

(d) Multi-Family Dwellings of either two (2) or three (3) units shall be required to have a ninety (90) gallon can per apartment unit. A properly sized dumpster is optional. Smaller sized containers may be allowed if the owner demonstrates that the volume of garbage is insufficient to require larger containers.

(2) PRIVATE CONTRACT. Any solid waste generator may contract directly with a licensed waste hauler for the disposal of garbage. Disposal of garbage through the use of dumpsters shall be by private contract.

(3) RECYCLABLE MATERIALS. Recyclable materials shall be handled as outlined in the Recycling Ordinance.

(4) REMOVAL OF CONTAINERS AND UNACCEPTABLE MATERIALS.

(a) Automated containers and unacceptable materials not collected by the automated system, shall be removed from the street right-of-way prior to 7:00 p.m. of the day of collection.

(b) Violators will be notified by a Delivery Confirmation Letter, along with a copy of the applicable ordinance.

(c) Continued violations shall be subject to a fine of \$20.00 per incident plus associated court costs.

(5) REFUSE STORAGE AREAS.

(a) Storage areas shall be kept in a nuisance and odor free condition. Litter shall not be allowed to accumulate. Collection crews will not be responsible for cleaning up loose materials which are not properly placed in approved containers.

(b) The owner/tenant shall be responsible for cleaning up any spilled materials. Violations will result in the tenant and/or owner being prosecuted under the provisions of this and other Village Ordinances.

(6) STORAGE OF CONTAINERS.

(a) Garbage containers shall be generally stored in an inconspicuous location, away from the street.
