From the Village Board – Highlights from the Regular Board Meeting:

The Village Board approved the following:

- To give TIF assistance (Developer Assistance Grant) to Nick & Vicki Mirsberger, LLC for a new building project and an office addition project in the amount of \$69,400.
- To give TIF assistance (Developer Assistance Grant) to CJF Estates, LLC for new home projects on Lots 30, 34, & 38 in the amount of \$69,800.
- To hire Robert E. Lee & Associates, LLC regarding their proposal for the drain tile on Cedar St.
- The final payment request in the amount of \$35,205 to MRD Group, Inc. and any outstanding bills to Cedar Corporation regarding the Bel Brands Property Project.
- To submit a final draw request to close out the Bell Brands Property Project.
- To pay the final fumigating invoice regarding the 3rd St. apartments with the agreement that no future invoices are to be paid by the Village.
