FROM THE VILLAGE BOARD-Highlights of the April Board Meeting:

The village board approved the following:

- Application for 6 month class B license for the Hilbert Athletic Association pending signatures.
- Appointment of Board Standing Committees and other annual appointments.
- To accept the sealed bid for the fire department's 1988 Chevy Step Van in the amount of \$1,865.00.
- Purchase and installation of carpet tiles for the village council room and hall.
- Hiring Cedar Corp as a consultant to write the WEDC Grant Application.
- Resolution 2017-02 Fair Housing Ordinance.
- Resolution 2017-03 to Adopt the Policy to Prohibit the Use of Excessive Force and the Barring of Entrances/Exits for Non-Violent Civil Rights Demonstrations.
- Resolution 2017-04 to amend the 2017 budget for the Village Development Plan.
- Committee recommendation for the preliminary resolution declaring intent to levy special assessments for curb & gutter portion of Hwy 114 project.
- The moving of the eastbound school crossing sign on Hwy 114 to west of 11th Street.
- Recommendation of no parking along Hwy 114 from 8th Street to 9th Street.
- The borrowing of funds to cover the shortfall on the 2017 Street Projects at approximately \$106,000.00.
- The installation of stone on the bank of the pond in Fox Trails Subdivision.
- The variance request from Paul Laabs on the requirement for dumpster to allow for individual containers for garbage/recycling.
- The formal collaborative agreement with the Eastshore Humane Association.
- The blocking off of the service road between the two ball fields in the park with the planters that were on Main Street.
- The placing of a street light on Sienna Ct.

The village received notice of the following:

- Lottery credit for Real Estate in the amount of \$42,014.70
- Lottery credit for Mobile Homes in the amount of \$3,788.52
- The receipt of the quarterly street aid payment in the amount of \$12,292.82
- The condition of budgets for all funds.
