From the Village Board – Highlights from the Regular Board Meeting:

**The Village Board approved the following:**

- Payment Request #1 to Highway Landscapers in the amount of \$88,207.98 for the Trail Project.
- The plan for the cluster box mailing units to be submitted to the postal service for Village Meadows Subdivision.
- Resolution 2022-02 to Dissolve the Hilbert Housing Authority since the sale of the Sunrise I and Sunrise II apartment buildings has closed.
- The Temporary Class B License for St. Mary's Church for their yearly event.
- For 8 Fireman to attend the WI State Fire Convention on March 11<sup>th</sup> and 12<sup>th</sup>; in the amount of \$1,032.00
- The Cross Connection Control Program and the procedure to follow for businesses in non-compliance.
- The job description, process for hiring and the advertising for the summer help position.
- Procedure of notifications for meetings so all Board members are aware of all meetings.
- Ordinance 2022-04 amending Section 11.01(4.04) of the Code of Ordinances: Sewer Use and Sewer Service Charge regarding private sewer systems that cannot be served by the public water and sewer system of the Village.
- Ordinance 2022-05 amending Section 8.08(8) of the Code of Ordinances: Well Abandonment regarding the installation of new private wells when the property cannot be served by the public water system.
- Resolution 2022-01 Authorized Representative for the DNR; the representative will be the Village Administrator Clerk Treasurer.
