From the Village Board – Highlights from the Regular Board Meeting:

#### The Village Board approved the following:

- Operator's license to Hiramani Bhusal.
- A Temporary Class B License to the Hilbert/Potter Optimist for their Bingo night on November 19<sup>th</sup> at the Hilbert Community Center.
- Resolution 2022-12 to Reclassify Reserve Funds from the Pulse Ox Meter Reserve Fund to the Radio/Pager Reserve Fund.
- The 2023 compensation package for Village employees.
- The 2023 Police Contract with Calumet County.
- The Fire Department contracts for 2023.
- The First Responder contracts for 2023.
- To increase the First Responder compensation for completing ward reports after each call from \$5 to \$10.
- The request by the Hilbert School District to hold a bonfire as part of the Homecoming activities.
- To have the Community Center's roof replaced by Prestige Roofing, LLC in the amount of \$17,640.
- To approve the listing contract from Keith Krepline (Coldwell Banker) for Village Meadows Subdivision lots.
- The Payment Request #1 to Feaker & Sons in the amount of \$383,257.94 for the Village Meadows First Addition Project.
- The Payment Request #1 to Korff Plumbing in the amount of \$32,453 for the 2022 Private Lead Service Lines Improvements.

# **Village Meadows Subdivision News**

We are happy to announce that the Village Board has conditionally approved an agreement with a developer that has the potential to bring in an additional 28 single family homes for the 2<sup>nd</sup> Addition (Phase 3) of Village Meadows. This agreement also includes the purchase of 3 additional lots in the 1<sup>st</sup> Addition (Phase 2) of Village Meadows. With this development, it has the potential to bring approximately \$9,000,000 in additional valuation to the Village.

#### **Trick-or-Treating and Halloween Party**

Following the trick-or-treating the Hilbert Revitalization Group will host a traditional Halloween Party from 3 p.m. to 4:30 p.m. at the Hilbert Community Center on 5<sup>th</sup> Street. This is a community event for Hilbert residents and for children and families attending public and private schools in the Hilbert School District.
