Highlights of the December Board Meeting:

The Village Board approved the following:

- Appointment of Andy King as the Village's attorney for 2020.

- Operator's license for Gloria Sandoval.
- Resolution 2019_10 Final Resolution to Levy Special Assessments for the Urbanization of South 8th Street.
- Resolution 2019_11 Declaring Public Depositories for 2020.
- Resolution 2019_12 to place 2019 budgeted items not being expensed before year end to respective reserve funds.
- The appointment of the Election Officials for 2020-2021.
- To authorize and approve the signing of the Subdivision Condition Report for Village Meadows Subdivision.
- The setting of the acreage for rental for 2020 for Village Meadows Subdivision Area with no changes from the previous year.
- The final pay request to MCC, Inc in the amount of \$9,058.55 for the 12th St./4th St./Chestnut St. project.
