From the Village Board – Highlights from the Regular Board Meeting:

The Village Board approved the following:

- Resolution 2022-07 regarding 2021 CMAR Report for the Wastewater Treatment Plant.
- Liquor, beer, soda and cigarette licenses for the upcoming licensing period of 7/1/22 to 6/30/23.
- Operator's license for Tara Eichmeier, Zach Propson and Charla Derks.
- Application for Temporary Class B License for the Hilbert Lions Club for the 4th of July Parade & Picnic and for the Vic Ferrari Band Concert on August 14, 2022.
- The setting of the prices for Phase II of Village Meadows Subdivision.
- To amend the covenants for Phase II of Village Meadows Subdivision; regarding if a house is built with a crawl space (since basements are not required).
- To send out requests for proposals for hiring a listing agent for Phase II of Village Meadows Subdivision.
- To proceed with the drain tile along the trail in Village Meadows Subdivision once the elevations are verified and verification that the next phase does not drain to the east.
- To proceed with repairs to the drainage ditch at the end of Creek St. and to obtain a temporary working easement to complete the work.
- Dennis DuPrey to attend the annual WMCA Conference on August 25th.
- To appoint Betty Ruppenthal as an election inspector.
- To, on a temporary basis, outsource the lab testing at the Wastewater Treatment Plant to help alleviate current work load for existing employees due to staff shortages.
- A variance for Kevin & Laurie Plate to foster 1 dog, from a shelter, on a temporary 6-month trial.
- To place a "For Sale" sign on the Village's property located on Main Street.
- The summer hours for the Village's employees.
- Fire Chiefs to attend the convention in Green Bay on June 24th.
- To order new safety vests for the Public Works Department employees.
- The employee health insurance renewal with the new plan as recommended by the committee.
- To move the August Board Meeting to Monday, August 8th due to the election.
- To have a new phone system installed at the Village Hall.
