From the Village Board – Highlights from the Regular Board Meeting:

The Village Board approved the following:

- The sale of a strip of land to the owner of Lot #13 in Village Meadows Subdivision to square off the property to their neighbors to the west in the amount of \$7,500 plus the buyer paying all costs associated to complete the sale.
- An operator license for Abigail Reimer.
- The purchase of the Cluster Box Units (mailboxes) for Village Meadows Subdivision in the amount of approximately \$6,297.
- To proceed with the infrastructure project for Phase II of Village Meadows Subdivision.
- The Restrictive Covenants for Village Meadows Subdivision, First Addition (Phase II) as amended.
- To adopt the fire chief job description as amended.
- To hire Ken Geiser for the summer help position.
- Resolution 2022-04 Reclassifying Reserve Funds.
- Ordinance 2022-06 Amending Ordinance 1_07 Board Salaries.
- Adding incentive for Public Works employees for completion of the Iron Removal Certification.
- To replace the barn door in the clerk's office with a solid door for more privacy during meetings.
- To allow a resident to install a drain tile by the pond in Fochs Trails Subdivision at his own expense.
- To purchase a temperature monitor for the wastewater flow in the amount of \$2,230.
- The request to place wording in an ad to sell property to promote possible investment incentives from the Village.
- To purchase additional safety equipment for the Public Works Dept. in the amount of \$804.40.

- Report from the Wisconsin Dept. of Revenue – Current Year Final Major Class Comparison.
