From the Village Board – Highlights from the Regular Board Meeting:

The Village Board approved the following:

- The Final Pay request to Highway Landscapers regarding the multi-use trail in Village Meadows Subdivision in the amount of \$4,642.53.
- To conduct a pilot program for phosphorus removal at the Wastewater Treatment Plant.
- The key holder agreement regarding the mailbox units in Village Meadows Subdivision.
- Operator's license to Jane Ladewig.
- For Mark Fochs to attend a review/study class in preparation for the Advanced Wastewater Certification testing in the amount of \$200.
- The contract with Robert E. Lee & Associates for engineering services for the request of the replacement of the water system Aquamag Feed Pump.
- To allow the closing off of Chestnut Street between 7th & 8th Streets during Gospel Fest.
- To grant a variance for the number of dogs allowed to two property owners.
- To remove the wooden stage inside the big pavilion at the Civic Park.
- The request from the Hilbert Lions & Hilbert Fire Department to use a couple of hours of the Village's contract with the Calumet County Sheriff's Department for the Vic Ferrari Concert being held on August 14, 2022 at the Civic Park in order to have police presence at the event.
