From the Village Board – Highlights from the Board Meeting:

### The Village Board approved the following:

- The proposal for the renewal of the Village's insurance for 2021.
- Change Order #2 for the 2019 Utility and Street Construction Project that resulted in a decrease of \$5,996.50.
- Change Order #3 for the 2019 Utility and Street Construction Project that resulted in an increase of \$30,624.18.
- Final payment to Jossart Brothers, Inc. for the 2019 Utility and Street Construction Project in the amount of \$192,391.63.
- The submitted plans for the house on Lot #10 in the Village Meadows Subdivision.
- The contract for Assessment Services from Action Appraisers regarding maintenance and market update services.
- To purchase fill for the Village Meadows Subdivision from Lunda Construction by using the proceeds from lot sales.
- The Santa Visit hosted by the Hilbert Fire Dept. on Thursday, December 3<sup>rd</sup> from 3 p.m. 6 p.m. and to block off that section of Main St. during the event.
- A variance requested by a resident to have 3 dogs at their residence.

#### 2021 Budget

The Village held their public hearing and approved the 2021 budgets for all funds. The total expenditures for 2021 are \$1,677,160 compared to \$1,239,217 last year. The Village tax rate will be \$8.030 compared to \$8.019 last year. Based upon a \$150,000 valued home, the Village's share of property taxes will increase by approximately \$1.79.
