From the Village Board – Highlights from the Regular Board Meeting:

The Village Board approved the following:

- Operator's license to Jodi Schaffer and Elizabeth Zahrobsky.
- Application for Temporary Class B License for the Hilbert/Potter Optimist Club for their Annual Bingo Event.
- Change Order Request #2 in the amount of \$11,439.40 due to additional asbestos removal for the Bel Brands Project.
- Payment Request to MRD Group, Inc. in the amount of \$202,253.00 for the Bel Brands Project.
- The 2022 contract for police protection in the amount of \$24,360.96.
- The final plat for Phase II of Village Meadows Subdivision.
- To grant the Housing Authority President, Village President and Village Administrator the authority to finalize all financial details for the closing of the Sunrise Apartment buildings; not to exceed \$50,000.
- To increase the petty cash amount to \$200 in the Clerk's Office.
- To set the December Board Meeting for Wednesday, December 8, 2021 @ 6 p.m.
- The proposal for the Corrosion Control Treatment (CCT) Study.
- To purchase a Chromebook for the use of the public works employees for meetings/training.

- The Notice of Preliminary Report on Major Class Comparison.

2022 Budget

The Village held their public hearing and approved the 2022 budgets for all funds. The total expenditures for 2022 are \$2,095,489 compared to \$1,677,160 last year. The Village tax rate will be \$7.682 compared to \$8.030 last year. The *estimated* decrease in taxes for residents will be approximately \$1 per \$1,000.
