- To accept the amendment to the Offer to Purchase to terminate the agreement for the purchase of the 3rd Street apartments.
- To accept the new offer for the 3rd Street apartments.
- To complete the blacktop patching.
- To pay for the new air compressor for the Fire Department through the general fund in the amount of \$1,222.61.
- Layout #3 (with changes) for the Phase II Development of Village Meadows Subdivision.
- Resolution 2021-01 to place a direct charge for public fire protection.
- Resolution 2021-02 Fair Housing Resolution which reaffirms the Village's Support for Fair Housing.
