From the Village Board – Highlights from the Regular Board Meeting:

The Village Board approved the following:

- Operator's license to Kim Baer and Nirmal Yogi.
- Resolution 2022-13 "Initial Resolution to Special Assess for Curb & Gutter" in regards to the Village Meadows Subdivision.
- Resolution 2022-10 Amending Ordinance 2.01 Traffic Laws; incorporating the stop sign on Tanglewood Way in the Village Meadows Subdivision.
- To set the local tax rate at \$5.558 compared to \$7.682 last year.
- The 2023 budgets for all funds.
- To set the public hearing regarding the special assessment for curb & gutter in the Village Meadows Subdivision for Tuesday, December 13, 2022 at 6:30 p.m.
- Change Orders #1 and #2 (increases) regarding the Phase II Development in the Village Meadows Subdivision in the amounts of \$9,000 and \$7,391.10.
- Payment Request #2 to Feaker & Sons in the amount of \$104,906.20 regarding the Phase II
 Development in the Village Meadows Subdivision.
- Change Order #2 in regards to adjusting the final extended completion date to April 30, 2023 for the Lead Service Lines Project in order to accommodate the DNR funding disbursement.
- The request from the Hilbert Fire Department to replace a lock at the fire station building.
