From the Village Board – Highlights from the Special Board Meeting & Regular Board Meeting:

## The Village Board approved the following:

- To rezone approximately 5 acres of land currently owned by Fox Valley Alfalfa Mill from Industrial to Single Family Residential.
- The formal collaborative agreement with the Eastshore Humane Society.
- Donation to the Eastshore Humane Society in the amount of \$420.97.
- Application for 6-month class B license on condition of the 15-day publication period with Steve Helms listed as the new agent Hilbert Athletic Association.
- Application for Temporary Class B Picnic License 4<sup>th</sup> of July Celebration by the Hilbert Lions.
- Operator's license for Kara Plansky and Kurtis Stephany.
- Appointment of Board Standing Committees and other annual appointments.
- The purchase and installation of a Mowstrip for the north ballfield.
- To replace the air conditioners at the Community Center building in the amount of \$13,725.
- The outdoor birthday party with live entertainment at 205 N. 8<sup>th</sup> St. on May 1, 2021.
