From the Village Board - Highlights from the Regular Board Meeting:

The Village Board approved the following:

- Ordinance 2022-08 Amending Section 4.08 of the Code of Ordinances Golf Carts; there no longer will be a registration fee/safety inspection needed for golf carts within the Village. Those residents who have already registered (expiring on April 30, 2024) will be getting notification in the mail regarding a refund.
- Ordinance 2022-09 Amending Section 4.08 of the Code of Ordinances ATV's; there no longer will be a registration fee/safety inspection needed for ATV's within the Village. Those residents who have already registered (expiring on April 30, 2024) will be getting notification in the mail regarding a refund.
- Resolution 2022-06 Declaring Intent to Levy Special Assessments; the installation of curb & gutter and paving on Thorn Creek Drive and Apple Blossom Drive in the 1st Phase of Village Meadows Subdivision and the installation of sidewalk on the north side of Thorn Creek Drive. The special assessment covers the installation of the curb & gutter and the remaining projects costs will be paid through a Village tax levy.
- The purchase and installation of a safety ladder at the Wastewater Treatment Plant from Sabel Mechanical in the amount of \$5,885.59.
- To appoint Jerin Van Cuyk as the Village's Emergency Government Director.
- The cost of the review class for the Advanced Wastewater Certification Test for Kim Plate, Public Works Director, in the amount of \$200.
- The contract with the Hilbert High School for baseball games being played at the ballfields.
- To share the cost of the dumpster at the ballfields with the Hilbert Athletic Association; with the HAA paying for June, July and August and the Village paying the other months.
